Races

All events will be held on Time Final basis.

Entry Restriction

Individual Events: no restriction on entries from each club.

Team Events: one (1) team per affiliate (club/school)

Eligibility

Only members from affiliates of Kuala Lumpur Amateur Swimming Association.

Age Groups

- Group 1 : 15 to 17 years (Born on 2/1/97 to 1/1/00)
- Group 2 : 13 to 14 years (Born on 2/1/00 to 1/1/02)
- Group 3 : 11 to 12 years (Born on 2/1/02 to 1/1/04)
- Group 4 : 9 to 10 years (Born on 2/1/04 to 1/1/06)
- Group 5 : 8 years and under (Born on 2/1/06 and after)

Date of Age Reckoning: 1st January 2015

Swimmers are only eligible to swim in their respective age grouping except for the 800 meters freestyle for Girls and the 1500 meters freestyle for Boys which are open events for age groups 1, 2 & 3.

Closing Date

Please submit your duly completed forms together with the respective entry fees to our secretariat before or latest by **08**th **January 2015**. Late entries will not be accepted.

Entry Fees

Entry fee is Rm4.00 per individual event and RM16.00 per team for the relay event. You are required to pay the entry fees in accordance with your entry list. Any scratching of events at the Team Managers' meeting shall have no effect on the amount as stated in your entry list. All entry fees must be paid the latest <u>at the Team Managers' Meeting</u> in cheque, made out to <u>Persatuan Renang Amatur Kuala Lumpur</u>.

Team Managers' Meeting

There will be a meeting for all Team Managers at Kuala Lumpur Swimming Complex on Saturday, 31st January 2015 at 8.00am.

Events Scratching

Events to be scratched are to be done at the Team Managers' meeting only. Penalty may be imposed for each event scratched on the day of the meet unless a medical certificate is furnished. A swimmer is deemed to be unfit to swim for the rest of the day on presentation of a medical certificate.

Events with less than 2 swimmers maybe swum combined with another age group. However, minus one rule applies. In the case of one swimmer, medal and medal count will only be awarded if the swimmer breaks the meet record.

Jury of Appeal

Jury of Appeal shall comprise of three (3) members from the Organising Committee and two (2) Team Managers from participating clubs not involved in the Appeal.
