- 4) RM25.00 penalty will be imposed on each event Withdrawn (WDR) on the day of the meet, Did Not Show (DNS) or Did Not Start (DNS) unless a medical certificate is furnished.
- 5) Qualifying Time for each event applies.
- 6) A fine of RM20.00 per event will be imposed on swimmer who does not swim within the Qualifying Time(QT).
- 7) Fill up the event no., official best time, consult the coaches and obtain coaches' signature before submitting.
Incomplete form will not be accepted.
- 8) This form and payment must be submitted to DSA administrative counter before the "Club Closing Date".
Late entries will not be entertained.
- 9) There will be no changes allowed after club closing date. Swimmers shall be charged for event entry fee of each event scratched after club closing date without any valid supporting document.
- 10) Coaches have the right to withdraw or add events for swimmer and it is finalized.
