- 6) Submit the Swim Meet form along with payment **in cash** to DSA Administrative Counter before "Club Closing Date". **Late entries will not be entertained.**
- 7) No changes allowed after club closing date. Payment will be forfeited without any valid supporting document.
- 8) Coaches have the right to withdraw or add events for swimmer and the decision is final.
