- 4) Individual Entry fee RM100.00/swimmer (regardless number of events entered), Relay entry fees RM24.00/event.
- 5) NO withdrawal will be entertained after submission to Organizer. Please submit event carefully.
- 6) Any withdrawals on the day(s) of the Meet with or without notification shall be deemed as "Did Not Show" or "Did Not Start". A penalty of RM50.00 shall be imposed on all DNS and is to be borne by the respective swimmer.
- 7) Penalty will be waived with a valid medical certificate furnished. A swimmer is deemed to be unfit to swim for the rest of the day on presentation of a medical certificate.
- 8) Fill up the event no., official best time (compulsory), and obtain coaches' consultation and signature before submitting. Incomplete form will not be accepted. Do not leave the best time portion blank. "NT" is not allowed.
- 9) Submit the Swim Meet form along with payment to DSA Administrative Counter before "Club Closing Date". Late entries will not be entertained.
- 10) No changes is allowed after club closing date. Payment will be forfeited without any valid supporting document.
- 11) Coaches have the right to withdraw or add events for swimmer and the decision is final.
- 12) This Meet is yet to be confirmed pending approval from the relevant authorities. Strict SOP will be adhered to.
