COMPETITION RULES & INFORMATION

1. Competition Dates

Friday 14th January to Sunday 16th January 2022

2. Competition Venue

National Aquatic Center, Kuala Lumpur Sports City, Bukit Jalil, Kuala Lumpur

3. Age Group	Open	: 17 to 25 years	(Born 2/1/1996 – 1/1/2005)
	Group I	: 15 to 16 years	(Born 2/1/2005 – 1/1/2007)
	Group II	: 13 & 14 years	(Born 2/1/2007 – 1/1/2009)

Date of reckoning for age group swimmers will be January 1, 2022. Swimmers can only compete in his or her own age group.

4. Entries

- 4.1 Entries are to be submitted through Hy-Tek and email to. The latest best times are to be submitted for seeding. The event file is as attached.
- 4.2 There is no limit to the number of entries for all individual events but each participating team is limited to one relay entry only.

5. Entry Fees

- 5.1 Individual events is RM10.00 per event
- 5.2 Relay events is RM40.00 per team per event
- 5.3 Entry fees must be paid prior to the competition date or at the Team Managers' Meeting in cash, cheque or interbank transfer to:-

Kindly email a copy of the payment confirmation / bank-in slip to as proof of payment for receipt issuance.

Upon checklist confirmation by participating affiliates, there will be no revision nor refund of the entry fees in the event of subsequent withdrawals/scratching.

6. Entry Closing Date

Entry closing date is **30th December 2021**.

7. Pool Side Entries

No pool side entries will be accepted. Changing of events or new events will not be allowed after the closing date.

8. Competition Rules

The competition will be conducted in accordance to FINA / WPS rules. The Organizing Committee reserves the right to decide on matters not provided for under the FINA / WPS rules.

9. Withdrawal/scratching of Event/s

Withdrawal or scratching of events is allowed at Team Manager's meeting only. A penalty of RM50 per event shall be imposed for each event withdrawn or "No Show" on the day of the competition.

If withdrawal of event is due to medical reason, a medical certificate must be furnished. The swimmer is deemed to be unfit for the rest of the day on presentation of a medical certificate.

10. Protest

Protest is allowed against the decision of the Referee. Protest must be submitted in writing by the Team Manager to the Referee within 30 minutes of the display of official results, accompanied with a deposit of RM300.00. If the Referee rejects the protest, he/she must state the reasons for the decision. The Team Manager may then appeal the rejection to the Jury of Appeal, whose decision shall be final.

If the protest is rejected, the deposit shall be forfeited by the Organising Committee. If the protest is upheld, the deposit shall be returned.

11. Jury of Appeal

Jury of Appeal shall comprise of two (2) members from the organizing committee and three (3) Team managers from participating clubs not involved in the appeal. The Technical Delegate shall be the chairperson of the Jury of Appeal.

12. Events to be contested

The swimming competition shall consist of the following events:

BOYS

Freestyle	:	50m, 100m, 200m, 400m, 1500m, 4 x 100m Relay
Backstroke	:	100m, 200m
Breaststroke	:	100m, 200m
Butterfly	:	100m, 200m
Individual Medley	:	200m, 400m
Medley Relay	:	4 x 100m Relay

GIRLS

Freestyle	:	50m, 100m, 200m, 400m, 800m, 4 x 100m Relay
Backstroke	:	100m, 200m
Breaststroke	:	100m, 200m
Butterfly	:	100m, 200m
Individual Medley	:	200m, 400m
Medley Relay	:	4 x 100m Relay

13. Competition Schedule / Order of Events

- 13.1 Heats will be swum in the morning at 08.30am whilst the Finals will be swum in the evening at 5.00pm.
- 13.2 800m and 1500m events will be swum as time finals with the fastest 8 seeded swimmers starting in the evening finals.
- 13.3 400m Individual Medley will be swum as time finals for Group I and Group II, boys & girls
- 13.4 Heats will be competed on 10 lanes. Finals will be-contested on 8 lanes.

14. Awards.

Certificate of Merit will be awarded to the Top 3 placing of each event. Certificate of Participation will be provided to all participants. We wish to notify there will be no medals this year.

15. Teams' Obligations

- 15.1 All teams and every individual must adhere strictly to the Covid-19 SOP as outlined by MKN/KBS
Any member not adhering to the Covid-19 SOP will be asked to leave the complex.
- 15.2 All team members and athletes must respect the facility of the venue. Should any damage be done by the athlete/official to any part of the premises, the team shall be held responsible in repair, make good to the satisfaction of the venue owner.
- 15.3 The team leader is to ensure that their team members and athletes observe proper cleanliness of their surrounding/area and to dispose of the food/drinks leftovers into the bin provided.
