By signing this form, I hereby confirm that the applicant (also known as the swimmer) and me, the guardian, has read carefully, agreed to and will follow all rules & regulations and abide by the terms & conditions applied by D Swim Academy Sdn Bhd and DSA/DSAS Swimming Club as listed

1. The swimmer is not attached to nor representing any other club/state; or has already resigned from the former club/state when this form is signed and during the whole training period with D Swim Academy Sdn Bhd.
 2. In the same year the swimmer must represent only DSA or DSAS Swimming Club and no other club for all eligible swim meets listed below:
 - a. MILO/PRAKL or Selangor Age Group Swimming Championship
 - b. MAS/NSC/Milo/Sport Excel Junior Swimming Circuit, 1st, 2nd & Final Leg
 - c. MAS/MILO/NSC Swim Splash Junior Series
 - d. National Inter-Club Swimming Championships - President Cup
 - e. Selangor Short Course, Selangor Long Distance & Selangor Novice Swim
 - f. Milo Age-Group Inter-Clubs Swimming Competition
 - g. Any other swim meets in which DSA or DSAS Swimming Club participates
 3. In the same year, the swimmer agrees to only participate in either PRAKL Age Group OR Selangor Age Group only and acknowledges that the swimmer is not eligible to participate in both swim meets within the same year.
 4. The swimmer may represent his/her school to participate in inter-school swim meets, and in the swim meets that DSA/DSAS Swim Club (swim club which the swimmer is registered to) is not participating. The swimmer must write in to DSA Squad Management prior to the event entry to check and confirm that no conflict is involved in the participation.
 5. DSA Swimming Club Members may participate under sister club DSAS Swim Club and vice versa in the below swim meets solely at D Swim Academy Sdn Bhd's discretion as all swimmers are trained by D Swim Academy Sdn Bhd. This is to encourage unity among all the DSA Swimmers and Parents irrespective of which Swim Centre or club members they are training with.
 - a) MAS/NSC/Milo/Sport Excel Junior Swimming Circuit, 1st, 2nd & Final Leg
 - b) MAS/MILO/NSC Swim Splash Junior Series
 - c) MAS/MILO/NSC Mid-Long Distance Swimming Meet
 - d) National Inter-Club Swimming Championships - President Cup
 - e) Milo Age-Group Inter-Clubs Swimming Competition
 - f) Swim meets organised by MAS or any other organisers
 6. The swimmer is not allowed to switch between DSA and DSAS swimming clubs within the year itself. The swimmer may sign up to the sister club in the next year but the application must be submitted as a **NEW MEMBER** with the **New Membership Fee** applicable for that year.
 7. All Club Membership fees cannot be pro-rated. Membership fees stated are applicable for the current calendar year.
 8. Swimmers found violating the terms & conditions will have their DSA/DSAS Swim Club Membership terminated and be suspended from all programs under D Swim Academy Sdn Bhd with immediate effect. Under such circumstances, the swimmer's re-registration to D Swim Academy Sdn Bhd and DSA/DSAS Swim Club in the future is not guaranteed and will require approval from DSA Management.
 9. Swimmers must give one month notice in writing if the swimmer wishes to resign from DSA Swimming Club or DSAS Swim Club. The swimmer's re-registration to D Swim Academy Sdn Bhd and DSA/DSAS Swim Club in the future is not guaranteed and will require approval
 10. Maximum deferment period is 6 months. Swimmers who stop training for more than the allowable deferment period will have their account, Junior Membership and e-Gold Tag terminated. Re-registration to D Swim Academy Sdn Bhd and DSA/DSAS Swim Club is not guaranteed and will require approval from DSA Management. The DSA Registration Fee and New Club Membership Fee of the year are required upon Management's approval for re-enrolment.
 11. DSA Management reserves the right to reject, omit or refuse service to any new or existing swimmers for any reason at any time.
 12. D Swim Academy Sdn Bhd reserves the right to change, amend, modify, suspend or terminate all or any part of the terms & conditions at any time without prior notice.
- e-Gold Tag and DSA/DSAS Junior Member Complementary Public Pool Usage Terms and Conditions:**
- a. The e-Gold Tag holder must be a direct parent of the DSA Swimming Club / DSAS Swim Club member.
 - b. One e-Gold Tag is for one person admission only whose name is registered together with DSA/DSAS Swim Club Membership.
 - c. The e-Gold Tag benefits and privileges are not transferable to another user.
 - d. The e-Gold Tag is only allowed to be used at the National Aquatic Centre@Bukit Jalil (Training Pool), Panasonic@Shah Alam, and Kompleks Sukan Paralimpik@Kampung Pandan.
 - e. e-Gold Tag Holders and DSA/DSAS Junior Members (SWIMMERS) MUST obtain a wrist band at the ticketing counter before entering the pool.
 - f. e-Gold Tag Holders and DSA/DSAS Junior Members (SWIMMERS) MUST abide by and follow the Public Session Schedules set by DSA management at all times. Public Session Schedules are available at the DSA ticketing counter or www.dswimacademy.com
 - g. e-Gold Tag Holders & DSA/DSAS Junior Members (SWIMMERS) MUST abide & follow all rules as per rules and regulations stated for the public.
 - h. DSA management reserves the right to withdraw the e-Gold Tag from any person that causes disturbances, behaves in an unacceptable manner or violates any rules and regulations.
 - i. The e-Gold tag is deemed invalid following swimmer's withdrawal/termination or the expiration of DSA Swimming Club or DSAS Swim Club Membership.
