## [C] TERMS &amp; CONDITION

- 1) Read the competition rules & regulations carefully.
- 2) This event is open to **All Nationality of DSA/DSAS Swim Club Members 2022.**
- 3) Open Age Group to Group 4 swimmers only. Refer to the swim meet rules for age grouping details.
- 4) **Qualifying time applies.** Kindly refer to the Order of Event List for qualifying times.  
A fine of **RM100 EACH EVENT** will be imposed on swimmer who does not swim within the Qualifying Time.
- 5) Entry Fee RM10.00 per event.
- 6) **Last withdrawal date is 7th December 2022 (Wednesday), 3pm.**  
Any withdrawals on the day(s) of the Meet with or without notification shall be deemed as "Did Not Start" (DNS).
- 7) **A penalty of RM25 per event shall be imposed on all DNS and is to be borne by the respective swimmer.**  
Swimmers with penalty must submit the penalty immediately to the Team Manager right after the event in order to continue to participate on that day. Swimmers will not be allowed to swim next event without payment.
- 8) Penalty will be waived with a valid medical certificate furnished. A swimmer is deemed to be unfit to swim for the rest of the day on presentation of a medical certificate.
- 9) Fill up the event no., official best time, **consult the coaches and obtain coaches' signature before submitting.**  
Incomplete form will not be accepted. **Do not leave the best time portion blank. Do not put "NT".**
- 10) Submit the Swim Meet form along with payment to DSA Administrative Counter before **"Club Closing Date"**.  
**Late entries will not be entertained.**
- 11) **Payment is acceptable in cash, credit card or e-wallet.**
- 12) **No changes allowed after club closing date. Payment will be forfeited without any valid supporting document.**
- 13) Coaches have the right to withdraw or add events for swimmer and the decision is final.
