DSA SQUAD PROGRAM HANDBOOK

Dear Swimmers and Parents,

Congratulations and welcome to DSA Squad Program – a place that nurtures the new generation with sportsmanship and team spirit toward their journey in competitive swimming!

Before getting started, let us walk you through the general information you will need when joining the program

1.0 REGISTRATION AS STUDENT OF DSA SQUAD PROGRAM

A swimmer who has been promoted from DSA Mini Squad/qualified after assessment to train in the DSA Squad Program is required to read, understand and sign the "Terms & Condition of Service for Squad Program" as the shift to a new program involves a different structure and policy.

2.0 PROGRAM STRUCTURE AND FEE PAYMENT

The Squad Program training sessions are offered at different frequencies to suit different needs:

Sports/Development Squad	Group C and D	8 or 12 Sessions	
Competitive Squad	Group A, B, and C	Unlimited Sessions	

^{*}Group A & B are allowed to opt for the 12 Sessions package twice in a year.

^{*}Group D may take the Unlimited Sessions package based on their coach's recommendation.

Newcomers from DSA Mini Squad will be assigned to the Sports/Development Squad (Group D) by default to build up the foundation. As the swimmer improves with time and training, they can look forward to progressing to Competitive Squad group.

Newcomers from another Swim Club/Swim School will be assessed according to DSA Grouping Requirements by a DSA Coach and will be advised on which Training Group to start with.

Training days are flexible in this program, swimmers can arrange their preferred training day according to the respective Swim Centre's training schedule, however it is recommended to commit to a consistent frequency with training.

Monthly training fee payments month shall be completed no later than the 7th day of the month at the DSA Administrative Counter or through DSA First Portal.

Payments not received by the 7th day of the month will cause the account to be suspended. An activation fee of RM10 will be applied to reactivate the suspended account.

No pro-rata of monthly training fee. No replacement and no carry forward of unused lessons to following month.

3.0 TRAINING GROUP

The DSA Squad Program has 4 training groups, namely Groups A, B, C & D, each with its respective qualifying times.

Newcomers from Mini Squad will be assigned to Sports/Development Squad (Group D) by default to build up their foundation skills. A swimmer can be promoted to a higher group through a series of procedures involving their best time achieved in a swimming competition for 100 LCM Freestyle, test set results and training commitment. The requirements will be reviewed annually or after a period deemed suitable by the coaches.

4.3 Training Program

DSA Squad Program combines a mixture of training involving water and land exercises.

It is the swimmer's responsibility to prepare the necessities for training such as running shoes, yoga mat and dry towel. Please consult the group coach if you are not sure which equipment to bring for water and land training.

5.0 TRAINING ATTIRES AND TRAINING EQUIPMENT

5.1 Training Attires: In DSA, we strongly suggest that swimmers wear swim attires which adheres to FINA (International Aquatics Governing Body) requirements. It is not advisable for swimmers to wear rash guards/wetsuits/dry-suits/two-piece suits for training so that swimmers would get used to FINA approved swim attires.

Swimmers with long hair are advised to wear a swim cap for hygiene, safety and training purposes.

5.2 Training Equipment:

Group A: Silicone training fins (short), Hand paddles, Pull-buoy/Kickboard, Training Snorkel (optional)

Group B: Silicone training fins (short), Hand paddles, Pull-buoy/Kickboard, Training Snorkel (optional)

Group C: Silicone training fins (short), Hand paddles, Pull-buoy/Kickboard, Training Snorkel (optional)

Group D: Silicone training fins (short), Pull-buoy/Kickboard, Training Snorkel (optional)

Training Fins are **COMPULSORY**. Non-training fins such as scuba diving fins, snorkelling fins and long rubber fins are not allowed.



6.0 DEFERMENT OF PROGRAM

Temporary deferment of training may be applied by submitting the form to DSA Administrative Counter; email to dsaswimteam@dswimacademy.com or Whatsapp to us at 0389993393.

All applications are required to apply 1 week in advance before the commencement of the deferment & **Advance payment** is required for returning month to avoid account being suspended, and collection of reactivation fee.

Deferment is only considered complete after payment is being processed.

A swimmer who defers for more than 3 months will be reassessed by the group coach to determine the swimmer's fitness and the coach holds the right to assign the swimmer to the Squad group that they deem fit.

Deferment period is minimum 1 month & maximum 3 months. Swimmers who stop training for more than the allowable deferment period will have their account, Junior Membership and Gold Tag terminated. Reregistration to D Swim Academy Sdn Bhd and DSA/DSAS/DSAJ/DSAP Swim Club is not guaranteed and will require approval from DSA Management. The DSA Registration Fee and New Club Membership Fee for the year are required upon DSA Management's approval for re-enrolment.

7.0 SWITCHING SWIM CENTRES

Swim Centre switches may be applied due to school schedules or personal activities, although it is not advisable as different coaches have different coaching methods. Consent from the current coach is **compulsory** in order to apply for a Swim Centre switch. Swimmers are not allowed to switch for more than 2 locations at each application.

The application is subject to DSA Management and respective coaches' approval. Once it is approved, the swimmer is required to follow the Swim Centre's training arrangements and there shall be no changes within 6 months unless due to group promotion or school matters with a valid reason and supporting documents.

Full Switch to Another Swim Centre:

a. Swimmer who wishes to permanently change to another swim centre

Switch between 2 Swim Centres:

- a. Swimmer who wishes to train between 2 swim centres
- b. If a swimmer decides to remain in one swim centre after the end of the period applied, they are required to reapply for a "Full Switch to Another Swim Centre".

Terms & Condition:

- a. All applications are subject to DSA Management and the respective coaches' approval.
- b. Application status will be notified via email within 7 working days.
- c. All applications shall be completed through online only.
- d. All applications must be submitted at least 7 working days before the commencement date in the new swim centre.
- e. Swimmer is required to follow the new swim centre's grouping and training arrangement, and there shall be no changes of swim centre within 6 months unless due to group promotion or school matters with a valid reason and the provision of supporting documents.

8.0 PRIVATE STROKE CORRECTION

Private Stroke Correction

For swimmers who wish to do private sessions with the coaches, approval from the Squad department is required before making any payments.

Terms & Condition

- a. Only applicable for active DSA / DSAS / DSAJ / DSAP Swimming Club members only.
- b. All applications shall be processed online, including payment.
- Application for Private Stroke Correction is required at least 3 days prior to the session's commencement.
- d. All applications are subject to management's approval.
- e. Applicants will be notified of their application status via email within 3 working days.
- f. Payment details will be provided upon approval.
- g. The application will only be considered completed after receiving the payment. Rescheduling of session must be requested on a minimum of 24 hours before the scheduled class or the fee paid will be forfeited, unless the request is accompanied by Medical Certificate. A written letter must be given to DSA when applying for a refund based on compassionate ground (e.g. misfortune to a family member).
- h. Cancellation within 24 hours from the scheduled class by the student/parent/guardians NOT ALLOWED. Fees paid will be a FORFEITED unless a Medical Certificate is provided.

DSA CLUBS GENERAL INFORMATION

1. MANAGEMENT OF SWIMMING CLUBS

D Swim Academy Sdn Bhd (DSA), is the appointed management to run the DSA Swimming Club (DSA), DSAS Swim Club (DSAS), DSAJ Swim Club (DSAJ) & DSAP Swim Club (DSAP).

2. STATE AFFILIATION & MANAGEMENT OF CLUBS

DSA Swimming Club – Affiliation with Persatuan Renang Amatur Kuala Lumpur (PRAKL)
DSAS Swim Club – Affiliation with Persatuan Renang Amatur Selangor (PRAS)
DSAJ Swim Club – Affiliation with Persatuan Renang Amatur Johor (PRAJ)
DSAP Swim Club - Affiliation with Penang Amateur Swimming Association (PASA)

As DSA is managing all the clubs, they are now affiliated with one another through DSA and are structured to be fully managed independently by DSA.

3.0 REGISTRATION AS JUNIOR MEMBER OF DSA CLUBS

DSA swimmers who wish to participate in swimming competition/meets will need to register as a Junior Member of DSA Swimming Club, DSAS Swim Club, DSAJ Swim Club or DSAP Swim Club. At DSA, we do not accept members of other swimming clubs besides DSA Swim clubs training in our Squad Program. It is **COMPULSORY** for all swimmers from another club or academy (as long as they are a non-DSA Mini Squad Graduate) to register and join as a Junior Member in order to train at DSA.

It is **optional** for graduates from DSA Mini Squad to join as Junior Members, however, swimmers **MUST** join DSA Swimming Club, DSAS Swim Club, DSAJ Swim Club or DSAP Swim Club in order to participate in swimming competitions, or if they wish to sign up to the Unlimited Sessions Package.

A swimmer can only choose **ONE** swim club (DSA Swimming Club, DSAS Swim Club, DSAJ Swim Club or DSAP Swim Club) in each calendar year. The Junior Member/Swimmer is not allowed to transfer/switch their membership between DSA Swimming Club, DSAS Swim Club, DSAJ Swim Club or DSAP Swim Club within the same calendar year.

3.1 MAS SWIMMER NATIONAL REGISTRATION

All DSA/DSAS/DSAP/DSAJ Swim Club members are required to register in MAS Swimmer National Registration in order to participate in all MAS (Malaysia Swimming) sanctioned events.

4. JUNIOR MEMBERSHIP TERMS AND CONDITIONS:

- a. Upon registration of Junior Membership, swimmers must clearly indicate the swim club they are signing
 up for the year. Only **ONE** swim club membership per Junior Member/swimmer is allowed. A swimmer is
 NOT ALLOWED to join more than one swim club in a calendar year.
- b. The Junior Member/Swimmer (Not applicable to Duality Membership) must be aware of their own respective contract/ agreement/memorandum that they have signed with their respective State/School/Club or any other organisation, to ensure their own eligibility in participating in any swim meets or swim training.
- c. The Junior Member/Swimmer must declare in writing to D Swim Academy Sdn Bhd, DSA Clubs, any contract/agreement/memorandum that they have signed with their respective State/School/Club or any other organisation prior to signing up with D Swim Academy Sdn Bhd, DSA Swimming Club, DSAS Swim Club, DSAJ Swim Club and/or DSAP Swim Club.
- d. D Swim Academy Sdn Bhd, DSA Clubs are not responsible for keeping track of the Junior Member/Swimmer's personal contract/agreement/memorandum that they have signed with their respective State/School/Club or any other organisation.
- e. The Junior Member/Swimmer must not be attached to, nor be representing any other club/state, or have already resigned from the former club/state upon signing up and during the whole training period with D Swim Academy Sdn Bhd.
- f. In the same year the Junior Member/Swimmer (Not applicable to Duality Membership) must represent only DSA Clubs and no other club for all eligible swim meets listed below:
 - a. MILO/PRAKL or Selangor Age Group Swimming Championship
 - b. SPORTEXCEL/MILO/NSC/MAS Junior Swimming Circuit 1st, 2nd & Final Leg
 - c. Junior Splash Swim Series
 - d. National Inter-Club Swimming Championship (President Cup)
 - e. Selangor Short Course, Selangor Long Distance & Selangor Novice Swim Meet
 - f. Any other swim meets in which DSA, DSAS, DSAJ or DSAP Swimming Club participates
- g. In the same year, the Junior Member/Swimmer agrees to participate in either PRAKL Age Group OR Selangor Age Group only and acknowledges that the Junior Member/Swimmer is not eligible to participate in both PRAKL and SAG swim meets within the same year. (Not applicable to Duality Membership)

- h. The Junior Member/Swimmer may represent his/her school to participate in inter-school swim meets, and in the swim meets that DSA Clubs is not participating. The Junior Member/Swimmer must write to DSA Clubs prior to the event entry to check and confirm that no conflict is involved in their participation.
- i. The Junior Member/Swimmer is not allowed to switch between DSA Clubs swimming club within the same calendar year. The Junior Member/Swimmer may sign up to the sister club in the next year but applications must be submitted as a new member with the new membership fee applicable in that year.
- į. Any Junior Member/Swimmer found violating the terms & conditions will have his/her DSA Clubs membership terminated and be suspended from all programs under D Swim Academy Sdn Bhd with immediate effect. Under such circumstances, the swimmer's re-registration to D Swim Academy Sdn Bhd and DSA Clubs in the future is not guaranteed and will require approval from the DSA Management.
- k. All Club Membership fees cannot be pro-rated. Membership fees stated are applicable for the current calendar year.
- I. The Junior Member/Swimmer must give one month's notice in writing if the Junior Member/swimmer wishes to resign from DSA Clubs. The swimmer's re-registration to D Swim Academy Sdn Bhd and DSA/DSAS/DSAJ/DSAP Swim Club in the future is not guaranteed and will require approval from the DSA Management.
- A Junior Member/Swimmer with more than 6 months inactivity/deferment will have their account suspended and club membership terminated. Gold Tags issued under the same membership application will be terminated as well. To reactivate the account, the swimmer has to re-register for DSA. A one-off Re-registration Fee applies along with the New Membership Fee for that year.

5. **DUALITY MEMBERSHIP TERMS & CONDITION**

Swimmers who train in DSA but wish to represent their School Clubs (affiliated to any state) in swim meets that DSA participates in

- a. Compulsory to enrol for Unlimited Sessions Training Package throughout the calendar year.
- **b.** Entitled to enrol for Private Stroke Correction & DSA SportsCare Programs.
- **c.** Entitled to attend selected events (eg. talks, swim clinics, swim camps).
- d. If Duality Member decides to represent DSA Clubs in swim meet which DSA participates, the member is entitled to the following benefits for that particular meet:
 - i) Complimentary refreshments
 - ii) Incentive scheme for WPKL, Selangor, Johor or Penang Age Group and/or President Cup
